- **P Perfect** Perfect condition either due to restoration or preservation. Original condition where all work has been carried out and completed to the highest quality.
- **E Excellent** Excellent condition, where the vehicle is fully restored or original with slight work required in order to reach the Perfect grade.
- **G Good** Good condition but where the vehicle is unable to reach the Perfect grade. No major issues or faults however lacks history and/or originality.
- S Standard Road worthy and is capable of obtaining an MOT Certificate but could use some TLC
- **U Usable** Driveable yet in need of substantial work for it to reach the Standard or Good grade.
