All you then need to do is send this form, the images as requested below with a cheque (or call us to pay by card) for the amount of £20.00 to cover our admin costs.	Once that has been done, just send the completed, verified form to us at the above address along with the requested images as stated below						

#### **IMAGES**

Images of your vehicle are required to accurately ascertain the vehicle value. We need at least four photographs of your vehicle, showing differing angles. At least one must show the registration number and preferably one of the engine bay and interior Remember, you know your vehicle better than we do!

#### **ONE LAST THING**

Here at Brentacre, we know as much as anyone how much cars cost to restore and how much sentimental value they hold, however, please make sure that you are realistic with your valuation. We reserve the right to question or even decline the application if we feel the value provided is not honest and true.
